Barry Johnson of the Camden County Sheriff's Office recognized five (5) Camden County Deputies who have just completed the 408 hour Georgia Basic Law Enforcement Training Course in Savannah.

He explained that Camden County Deputies distinguished themselves among their classmates - Robert Averdisian held the office of Class President , Stephen McKinney held the office of Class Vice-President, Kennith Adams made the highest average for the class on the firing range, and the class as a whole graduated with an academic average of 98%. He stated that as a part of their training the students are required to complete a three (3) day emergency vehicle operations class in Forsythe, Georgia. He explained that those students who are unable to complete this vigorous training do not graduate and in all of the years that the police academy has been in Savannah, Georgia, never has a class had 100% pass rate. He stated that the Camden County Deputies now are among the class that holds that distinguished honor, and in honor of their accomplishment an orange cone is now on display at the academy.
