

**RESOLUTION OF THE CAMDEN COUNTY BOARD OF COMMISSIONERS
TO AMEND PREVIOUSLY ADOPTED RESOLUTION REGARDING THE
COMPENSATION FOR THE CAMDEN COUNTY BOARD OF TAX ASSESSORS
PURSUANT TO O.C.G.A SECTION 48-5-294: COMPENSATION:**

WHEREAS, Camden County, Georgia, a political subdivision of the State of Georgia by and through the Board of Commissioners is vested with the lawful authority, pursuant to O.C.G.A. section 48-5-294: COMPENSATION; to establish the compensation for the Camden County Board of Tax Assessors; and

WHEREAS, O.C.G.A. Section 48-5-294: COMPENSATION: states: "Each member of the county board of tax assessors shall be paid as compensation for his services an amount to be determined from time to time by the county governing authority. The compensation to be paid to a member of the board shall not be less than \$20.00 per day for the time he is actually discharging the duties required of him. Attendance at required approved appraisal courses shall be part of the official duties of a member of the board and he shall be paid for each day in attendance at such courses and shall be allowed reasonable expenses necessarily incurred in connection with the courses. The compensation of the members of the board and other expenses as may be necessarily be incurred in the performance of the duties of the board shall be paid from the county treasury in the same manner as other payments by the county are made."; and

WHEREAS, a previous Board of County Commissioners, by resolution and policy, established the compensation for the members of the board of tax assessors; whereby the chairman of the board of tax assessors is paid \$250.00 per month with the remaining members of the board of tax assessors each being paid \$200.00 per month; and

WHEREAS, O.C.G.A. section 48-5-294 grants to the Board of Commissioners the lawful authority to establish compensation for the board of tax assessors in an amount to be determined from time to time; and

WHEREAS, the Board of County Commissioners now desires to amend and set aside the previously adopted resolution and policy that established the compensation for the members of the board of tax assessors at the afore-stated amount of \$250.00 monthly for the chairman and \$200.00 monthly for each remaining member; and

WHEREAS, the Board of County Commissioners now desires to compensate the members of the Camden County Board of Tax Assessors in the amount of \$20.00 per day for their lawful services for the time a member of the board of tax assessors is actually discharging the duties required by law; this policy shall further required a member of the board of tax assessors to certify by written document on a monthly basis that said member has performed the duties as required by law upon his request for payment of the aforesaid \$20.00 per day as envisioned by O.C.G.A section 48-5-294; and

NOW THEREFORE BE IT RESOLVED, this Resolution came before the Camden County Board of County Commissioners at a lawfully scheduled assembly on Tuesday April 7, 2009; and

NOW THEREFORE BE IT FURTHER RESOLVED the Camden County Board of County Commissioners after discussion and debate does by a majority roll call vote of the Board

of County Commissioners establish that the compensation for the Camden County Board of Tax Assessors to be established at a fee of \$20.00 per day for the time a member is actually discharging his lawful duties as defined in Title 48 of the Official Code of Georgia Annotated as amended from time to time by the State of Georgia Legislature; and

NOW THEREFORE BE IT FURTHER RESOLVED that each member of the Camden County Board of Tax Assessors shall certify by written affidavit, sworn to under oath, on a monthly basis, the lawful duties said member performed, with the member's signature affixed thereon. The document shall be delivered to the Camden County Finance Department on the last business day of the month that said member that is seeking compensation for lawful services performed as a member of the Camden County Board of Tax Assessors; and

NOW THEREFORE BE IT FURTHER RESOLVED the Chairman of the Camden County Board of County Commissioners is to affix his signature to this Resolution upon adoption by the lawful vote of the Camden County Board of County Commissioners.

Adopted in a lawful assembly by majority roll call vote of the Camden County Board of Commissioners and spread upon the Official Minutes.
