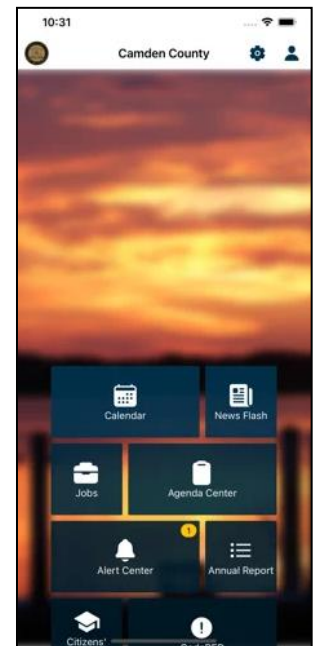
# Redesigned Mobile App Now Available

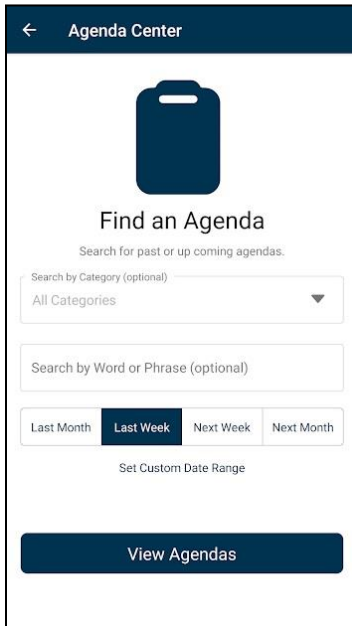
