Woodbine, GA – September 14, 2010: **REMINDER** – The deadline for the “Showcase Camden County” Photo Contest is quickly approaching on Monday, November 1, 2010. This contest calls for photographers to submit their best photos of Camden County, Georgia to include its activities, attractions and events, as well as historic and scenic locations. Camden County’s natural landscapes and unique events provide limitless creative inspiration to individuals that enjoy seeing the world through the lens of a camera.

The contest calls for photos to be submitted from one of four categories: **Landscapes, Nature/Wildlife, Architecture, Special Events/Festivals**. Contestants may submit no more than two (2) entries per category which allows contestants to submit a total of eight (8) entries if they so desire. A winner will be chosen from each of the categories and will receive a \$50 Visa gift card. An overall winner will be chosen among the winning photos from each of the four categories and will receive an additional \$100 Visa gift card, as well as their photo will be featured on the cover of Camden County’s 2010 Annual Report. All photo contest winners will be publicly recognized during a Board of County Commissioner’s meeting.

The photos that are submitted will be used by Camden County Government in its ongoing promotions and appropriate credit will be given to photographers when their photos are used. The winning photographs will be showcased at Camden County’s Government Services Complex, as well as various other locations throughout Camden County.
